## Cartus Awards College Scholarships to Three Students

Dinkins, headed for the University of Redlands, will pursue a focus in both pre-medicine and business, and hopes to become a doctor with a specialty in women's health.

"Leadership, inquisitiveness and an appreciation of community are key components of truly exceptional students," said Meichner. "All three recipients have demonstrated these qualities in extraordinary ways throughout high school. We're thrilled to support them as they prepare to do great things in college and in their future careers, as well."

This is the seventh year that Cartus has offered its Scholarship Awards. To date, the company has distributed \$29,000 to college-bound children of Cartus employees.
